Recognition was accorded for classes VIII to X (E.M) for the academic year 2013-14, in respect of Dav Ps Vijayapuri North, Pylon Colony, Ward Number Eleven-11(v), Peddavura(m), Nalgonda(dist).

The Correspondent of Dav Ps Vijayapuri North, Pylon Colony, Ward Number Eleven-11(v), Peddavura(m), Nalgonda(dist) has submitted the proposals for grant of Renewal Recognition of classes VIII to X (E.M) (with one section) from the year 2023-24 to 2032-33.

The Mandal Education Officer, Peddavura, Nalgonda has verified the proposals with reference to the conditions laid down in the Recognition orders and GO Ms No 1/Edn, Dated: 01-01-1994 and subsequent Government Orders submitted a detailed report through the letter

After careful examination of the proposals of the Correspondent and report of the Mandal Education Officer, Peddavura, Nalgonda based on the recommendation of the District Education Officer, Nalgonda, the Regional Joint Director of School Education, Hyderabad is pleased to accord the Renewal Recognition of Classes VIII to X (E.M) (with one section) for a period of ten (10) years from 2023-24 to 2032-33 in respect of Dav Ps Vijayapuri North, Pylon Colony, Ward Number Eleven-11(v), Peddavura(m), Nalgonda(dist). The management is requested to follow the conditions.

1. The above Renewal Recognition is accorded purely on a temporary basis and is subjected to the reports of State Level Inspection and Vigilance Committee fulfilling of all the pre requisite condition under the A.P Education Act 1982 and if later found that the school has not fulfilled any pre requisites as stipulated, the Renewal Recognition now being given is liable to be withdrawn at any time.

2. That the society shall abide to the rules and regulations made in the Govt. Orders 1st cited and subsequent orders.

3. That the Society shall provide the necessary amenities like accommodation sanitary facilities, drinking water facilities, furniture, Library, Laboratory, equipment play field required staff as per the staff pattern another facilities.
4. That the Renewal Recognition is accorded to the DAV COLLEGE MANAGING COMMITTEE.
5. The Renewal Recognition is accorded to run the school in the locality and there shall not be any change in the premises of locality specified in the orders.
6. The management should follow the G.O.Ms.No.22 ,dated 18-07-2017 i.e ., the weight of the school bag not to exceed 4kg for VI-VII, 4.5 kg for VIII-IX and 5 kg for X.
7. That the administrative report and the audited statement of accounts of the school duly attested by the Chartered accountant for every financial year shall be submitted to the District Educational Officer, latest by September
8. The Management has to follow the government norms from time to time, for collection of fee from students.
9. That educational agency shall not use the premises building, play ground and vacant site belongs to the institution for any purpose other than the Educational activities and conducting authorized examinations without permission of DEO.
10. The management should follow the guidelines issued in G.O.Ms. No. 36., School Education (General) Dept., Dt:- 16-12-2017 for the safety and security of the children in the schools.
11. The management should pay the mandate taxes due to the concerned departments as per schedule fixed by the Government.
12. The school shall follow the traffic and safety guidelines indicated by the police and fire services departments
13. The school shall have 'first aid-kit' and the teachers shall be trained in first aid.
14. That any children studied in recognized school of other states/countries affiliated to the bodies recognized by the state or central government shall not be admitted without prior permission of the District Educational Officer/Director of School Education.
15. That the management shall not collect any fees or donations either in cash or kind other than the fees prescribed by the governing body from pupils or parents or any other person or on their behalf for any purpose.
16. That educational agency shall not force any member of the staff or students of the institutions to take part in the religious discourses and preaching of religion irrespective of whether they belong to the same belief or not.
17. If the Management provides transportation, it is the responsibility of the Management to submit Fitness Certificates of their buses every year regularly to the D.E.O. to have skilled, Trained, Licensed and healthy driver. If any deviation in this matter, they will be personally held responsible.
18. The Correspondent should submit Renewal of Recognition proposals before 90 days of the expiry of Renewal Recognition.

19. The Educational Agency should Implement the Guidelines for Safe and Effective use of Internet & Digital Technologies in schools and school buses issued by CBSE vide Circular No.Acad-32/2017, dated 18.08.2017 communicated by MHRD, Govt. of India.

20. The Educational Agency should Implement the Model Education Code prepared by National University for Educational Planning and Administration in 2015

21. That educational agency shall not permit the students of any D.Ed/B.Ed colleges or college of physical education or any teacher training institution to have teaching practice without the permission of the District Educational Officer.

22. Proper and adequate parking area for vehicles shall be provided transporting the children to and from the school.

23. Proper and adequate safety measures shall be taken for children within the school campus and also near the school premises.

24. The Parent Teachers Associations meeting shall be conducted to sensitize the parents on the safety of the children

25. The school shall constitute Committees for redressal of the Public/ Staff/ Parents/ Students grievances, Internal Complaints Committee on Sexual Harassment and Committees under POCSO (Protection of Children from Sexual Offence) Act, 2012 and details of these Committees along with contact details shall be displayed prominently on School Notice Board and conspicuously on the School Website for the information of all the stakeholders.

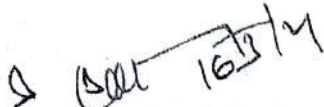
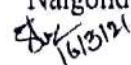

After careful examinations of the proposals received through 4th read above with reference to the instructions under reference 1st to 3rd cited, as per powers delegated through reference 1st cited, the District Educational Officer, Nalgonda is pleased to accord Renewal Recognition to LKG to VII (EM) class(es) U/A for a period of [10] years commencing from the academic year 2021-22 to 2030-31 in respect of D.A.V U.P.School, Nagarjunasagar, Peddavoora (M), Nalgonda District.

1. That the society shall abide by the instructions / rules regulations made by the Govt. or authorized Officer time to time.
2. That the Educational Institution shall serve the needs of the locality more particularly.
3. That the institution shall adopt the curriculum and syllabus prescribed from time to time.
4. The School timings vacations and Mid-term holidays shall be as prescribed by Government from time to time.
5. That the qualified staff with in the age limits prescribed by the Govt. for Govt. Employees shall be appointed as per the staff pattern.
6. That the results of Institution shall be satisfactory every year.
7. That the records/accounts shall be furnished to the District Educational Officer every year by 30th September at the latest.
8. The list of governing body shall be furnished to the District Educational Officer every year.
9. That the pay structure / Fee structure fixed by the Governing Body shall be got approved by the District Educational Officer every year.
10. That all the conditions prescribed in the G.Os and other orders, which are notified in these orders, shall be complied with.

11. That the school shall not be closed without giving notice both to the parents / D.E.O and competent authority at least 6 months before.
12. That the school shall be closed or permission to close only from the date on which summer vacation is declared.
13. That the society shall submit proposals for renewal of provisional recognition sufficiently in advance i.e., at least 6 months prior to the date of expiry of the renewal.
14. That the School shall be enrolled in DCEB, Nalgonda and following school timings, term holidays like Dasara, Sankranthi and declare 2nd Saturday as a holiday strictly.
15. Medical inspection should be done invariably every year
16. The recognition is accorded for **LKG to VII (EM)** classes with Single sections only (each class) and further the management shall have no right to open additional classes/sections without prior permission.
17. The Management has to follow the Government norms from time to time, for collection of fee from students.
18. The School shall run only in the address shown in the proposals. There shall not be any deviation under any circumstances.
19. The RTE Act, 2009 must be implemented. All the admissions, fee, salaries, physical facilities should be as per RTE Act, 2009. Failing which, the Management will be held responsible for consequences.
20. If later found that the school has not fulfilled any as stipulated, the recognition now being given is liable to be withdrawn at once.
